WHEN DO TRANSACTIONS POST TO MY ACCOUNT?

Horizons@Home transactions are live and instantly post to your account.

HOW LONG CAN I STAY LOGGED IN?

You have unlimited time to make transactions, but if your connection is inactive for more than 10 minutes, Horizons@Home will automatically log you off for your security.

IS MY INFORMATION AND ACTIVITY SECURE?
